- CDs were opened at the Bank of Cooperstown on December 13<sup>th</sup>, 2019. Three separate 18-month CDs were opened: Friedman Fund (\$10,264.08), Wright Fund (\$3,221.33), and Bequest II (\$5,020.28). The interest rate is 1.75%. The CDs have only one authorized signer Board Member Beth Baldwin Treasurer Clarissa Riker will be added as a second authorized signer at a later date.
- Discussed holiday raffle of Scholastic books. Books costing \$17 were purchased and will be raffled off in 4 different groupings. The cost was posted to L7410.410 Books, however, because these are for a raffle rather than the library collection, the cost should be posted to L1990.400 Special Items.
- Discussion ensued regarding "negative items" in certain expense categories where we have already spent more than what was budgeted. See L7410.402 Miscellaneous/Petty Expenses, L7410.405 PO Box Postage and L7410.411 Processing. Adjustments should be made to the budget to reflect actual spending. However, in some cases, the funding for these expenses was received in the prior fiscal year, with the cost being reflected in the current fiscal year. For example, money for the newsletter was partially funded from a grant received from the Unadilla Community Chest in December 2018, but the cost for production of the newsletter (Miscellaneous/Petty Expenses) and postage (PO Box Postage) occurred later in June 2019. Check with Clarissa to see if we can move money from our Fund Balance in this case, or would we have to move money from other current fiscal year line items?

\*Received a \$500 donation from the Community Chest on December 12th. We did not submit a grant request. This donation was not made for a particular purpose.
