- Mayor Cotten provided an update on various matters affecting the village. He wanted
  to discuss placement of the new electronic sign, which has been delivered and is ready
  to be installed. After reviewing possible options, he believes the new sign will need to
  be placed where the library sign currently is. The library sign could be moved closer to
  the building to the left of the sidewalk. Motion was made by Lois Baldwin and seconded
  by David Lapointe to put the existing library sign in the triangular section of lawn in front
  of the library. All agreed.
- Discussion ensued regarding the CDs invested at SFCU. The CDs are due to mature on September 20<sup>th</sup>, 2022. The best rates right now are for longer terms. SFCU is offering 32-month CDs at 3.16%. Board members agreed to renew each of the current CDs (L202/L203/L206) for 32-months at 3.16%. Board members also agreed to transfer

\$20,000 from the Money Management Savings Account, which current earns interest at .15%, into a 32-month CD at 3.16%.

As per the March 21, 2022 minutes, Clerk-Treasurer Kelly Jones still needs to be added as an authorized signor for the bank accounts at SFCU, along with Susan Barnhart and Beth Baldwin. All have joint/equal rights to make deposits, withdrawals, and receive statements. Clarissa Riker will be removed from the accounts.
